## **Centre Fees**

**UK Centre Approval Fee - £400**

Centres applying to offer or add qualifications which require a pre-approval site visit may incur the applicable fee for an additional External Quality Assurance visit as listed below.

Centres will have 6 months from the date of payment of the approval fee to complete their application, otherwise a further centre approval fee will become payable.

**Minimum Threshold** – All UK centres will be subject to a minimum annual spend of £1,000 on registrations covering the period of 1st January 2017 to 31st December 2017 (calculated pro-rata for centres approved during the calendar year). Centres that do not reach the minimum threshold will be invoiced for the difference between their actual spend and the minimum threshold on 1st January 2018.
